## End of share buy-back programme for free-of-charge allocation of shares to employees

Modena – 19 December 2022. BPER Banca informs that 15 December 2022 marked the end of the ordinary share buyback programme - launched on 7 December 2022 and disclosed to the market in the press release issued on 6 December 2022 - which was functional for the free-of-charge allocation of BPER Banca ordinary shares to the employees of the Group as part of the 2022 MBO incentive plan and any severance payments due. The shares were purchased under the terms approved by BPER Banca's Shareholders Meeting of 20 April 2022.

As required *inter alia* by art. 113-*ter* of Legislative Decree No. 58 of 24 February 1998 (the Consolidated Law on Finance), Article 5 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council of 16 April 2014 and Article 2 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016, details of the purchase transactions made are provided below.

In the 7 days of programme execution (7, 8, 9, 12, 13, 14 and 15 December 2022), BPER Banca - via Equita Sim S.p.A., the intermediary appointed to lead-manage the programme – purchased a total of 750,000 BPER Banca S.p.A. ordinary shares, corresponding to approximately 0.07% of the share capital, for a total consideration of EUR 1,441,097.00 at an average purchase price per share of EUR 1.9215.

The purchase transactions were carried out in compliance with the provisions of Articles 2357 and 2357ter et seq. of the Italian Civil Code and within the share number and amount limits set forth in the authorisations by the Company's relevant decision-making bodies.

Pursuant to Article 132 of the Consolidated Law on Finance and Article 144-bis of the Issuers' Regulation as later amended, the purchases were carried out on the regulated *Euronext Milan* (former MTA) in compliance with the operating procedures laid down for these transactions in the rules governing the organisation and management of the market.

The purchase transactions were also carried out in compliance with the conditions and restrictions set forth in Article 5 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council of 16 April 2014 and Articles 2, 3, and 4 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016.

Pursuant to Article 3 (3) (b) of Delegated Regulation (EU) 2016/1052, the daily volume of purchases did not exceed 25% of the average daily volume of the BPER Banca ordinary shares traded in the 20 trading days preceding the date of purchase.



The daily purchases of BPER Banca S.p.A. ordinary shares carried out on the regulated *Euronext Milan* from 7 to 15 December 2022 are reported in an aggregated form in the table below.
