Al momento, gli impegni sottoscritti ricevuti dalla Banca ammontano all'11,75% del capitale sociale, oltre a quanto comunicato nel pomeriggio dalla Malacalza Investimenti S.r.l. che ha dichiarato di "confermare ancora la propria attitudine di sostegno nell'interesse della Banca del territorio e dell'azionariato tutto".

Malacalza Investimenti S.r.l. ha altresì dichiarato di "aver presentato istanza all'autorità di vigilanza già dal 26 ottobre 2017 per essere autorizzata a incrementare la propria partecipazione nella Banca sino alla quota pari al 28% del capitale sociale della

medesima".
